CONFIDENTIALITY:

All hypnosis sessions are confidential. Mary Lou Blount Rodriguez will not release any information to anyone without written consent from you, the client, except as provided by the law.

EDUCATION AND TRAINING:

I graduated with my basic training hypnotherapy program at the Northwest Hypnosis Institute in Oregon. I followed up my basic training with one of the finest hypnotherapy program in the nation, an advanced program called 5-PATH, taught by Erika Flint at the Cascade Hypnosis Center in Bellingham, Washington. I am registered and certified 5-PATH hypnotherapist as well a certified member of the National Guild of Hypnotists. I participate in continuing education to maintain my training at a high level.

I am not a physician nor a licensed health care provider and may not provide a medical diagnosis nor recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis or any other type of treatment from a different practitioner, the client may seek such services at any time. In the event my services are terminated by a client, the client has a right to coordinated transfer of services to another practitioner. A client has a right to refuse hypnotism services at any time. A client has a right to be free of physical, verbal, or sexual abuse. A client has a right to know the expected duration of sessions, and may assert any right without retaliation.

In my practice I use hypnosis to help people discover the subconscious reasons for their symptoms, behaviors, or habits. When they are discovered, I use certain tools and techniques to help the client release them and relearn new positive way of thinking, subconsciously.
